

ORDINANCE 2024-02 Amendment to 2023-05

**TO DESIGNATE ALL STREETS INSIDE THE VILLAGE AS NO THRU TRUCK
STREETS**

BE IT ORDAINED by the Council of the Village of Tremont City, State of Ohio:

WHEREAS, no person shall operate a tractor-trailer regardless of weight; a double-axle truck, regardless of weight; a single-axle truck exceeding a gross weight of 5 tons; or any other motor vehicle exceeding 5 tons upon any street in the municipality except when travel inside the Village was necessary to make a delivery or pickup;

WHEREAS, Exemptions to this ordinance:

- Trash hauler contracted by the Village
- School bus
- Agricultural Vehicles
- Emergency response vehicles
- Utility company vehicles
- Clark County or German Township, Ohio road maintenance vehicles

WHEREAS, The Police Chief or Mayor can issue a single use permit to allow applicants to move an oversized or overweight vehicle via the Village streets. An application fee of \$150 per permit will apply;

WHEREAS, Signs will be posted No Thru Trucks over gross limit of 5 tons or words of similar import to apprise drivers of the limitations imposed by this ordinance. No driver shall disobey the instructions indicated on any such sign;

WHEREAS, no owner and or employer of any driver of any truck shall cause his employee and/or driver to purposefully violate this ordinance. Such violation by an owner, operator and/or employer shall be deemed a first-degree misdemeanor and will be cited into the Village of Tremont City Magistrate Court.

Any person who shall violate any provision of this Ordinance, shall, upon conviction, be fined in an amount of \$450. Each violation shall constitute a separate offense.

THEREFORE, BE IT RESOLVED, that Ordinance 2024-01 is hereby adopted this 12th day of February, 2024.
