

COOPERATIVE AGREEMENT

UPPER VALLEY PIKE IMPROVEMENT OPWC PROJECT 2024

This Cooperative Agreement is entered into between the **Board of Clark County Commissioners** (on behalf of Clark County, Ohio) and the **Village of Tremont City, Ohio**.

The County and the Village of Tremont City collectively are referred to as the Parties.

WHEREAS, the Board of Clark County Commissioners has submitted an application to the Ohio Public Works Commission for the Upper Valley Pike Improvement Project 2024; and

WHEREAS, a condition for OPWC granting the funds, and making payment directly to vendor(s) selected by the Parties, is for local entities (such as the Parties) to provide funds for a local match for the OPWC funding, equal to 26% of the amount to be paid to the chosen vendor(s); and

WHEREAS, as part of the process, OPWC requires the Parties to enter into a cooperative agreement so that the Parties, individually and collectively, agree to be responsible for paying its share of the local match, and to allocate responsibilities for the administration of the Project, including advertisement, bidding, award and contract administration.

THEREFORE, the Parties agree as follows:

The Board of Clark County Commissioners will provide funds equal to 100% of the local match required for the total cost of work to be performed on Clark County roads (Upper Valley Pike from Ross Lane to County Line Road, except that portion within Village of Tremont). Such monies will be paid from a fund or funds from which such costs may be paid under Ohio law. The Board of Clark County Commissioners agrees to pay its Local Share of the cost as invoices become due as agreed upon with any vendor(s).

The Village of Tremont City will provide funds equal to 100% of the local match required for the total cost of work to be performed on village roads (Upper Valley Pike aka Mulberry Street - All that portion located within Village of Tremont corporation limits). Such monies will be paid from a fund or funds from which such costs may be paid under Ohio law. The Village of Tremont City agrees to pay its Local Share of the cost as invoices become due as agreed upon with any vendor(s).


The Board of Clark County Commissioners agrees to be the party responsible for initial payment of costs under any contract awarded for the Project, and to seek reimbursement from the Village of Tremont City for any costs attributable to work on village roads (as defined in the previous paragraph). The estimate for the Village of Tremont City's costs is \$146,844 with the 26 percent local share to the OPWC match being \$38,179.44. Once the Board of Clark County Commissioners gives written notice of the actual cost attributable to work on village roads as

part of the project, the Village of Tremont City shall pay the requested reimbursement as such: \$10,000 per year maximum until paid in full with the first payment due before December 31, 2024.

Pursuant to Section 9.482 of the Ohio Revised Code, Village of Tremont City hereby authorizes the Board of Clark County Commissioners to serve as lead agency for purposes of applying for the OPWC grant, to execute all necessary documents to effectuate the receipt and use of the OPWC funds, to solicit bids for the project, and to take any other necessary actions to administer the contract that is awarded.





Commissioner Rittenhouse moved, per the request of County Engineer, to authorize the following inter-governmental agreement:


Agreement between: The Board of Clark County Commissioners and the Village of Tremont City
