Emergency Ordinance to Amend ORDINANCE 2024-20

CONTRACTING CHRISTINA FLOOD AS MAGISTRATE COURT CLERK  
FOR THE VILLAGE OF TREMONT CITY

BE IT ORDAINED by the Council of the Village of Tremont, State of Ohio:

SECTION 1. That I, Christina Flood, is hereby contracted as magistrate court clerk for the Village of Tremont City starting January 1, 2025 thru December 31, 2025.

Terms of Contract

The above appointment to, and acceptance of clerk for the magistrate court for the Village of Tremont City, Ohio, is made under the following terms:


- 1) The village will provide bonding insurance for the position of Magistrate Court Clerk
- 2) The village of Tremont City shall provide compensation in the amount of \$325 monthly, \$162.50 to be paid on the 15<sup>th</sup> and 30<sup>th</sup> of the month.
- 3) At the discretion of the mayor and with the approval of the village council, the amount of compensation may be amended at any state council meeting while this contract in in effect.
- 4) The village shall provide all forms, supplies, stationary, and stamps, and will reimburse for related expenses incurred to fulfill the required duties of the position.
- 5) As this is a contract, the appointee will be responsible for all federal and state taxes, and if applicable, proof of Bureau of Worker's Compensation coverage.
- 6) Either party may cancel this Contract by giving a written notice to the other party thirty (30) days prior to such cancellation.
- 7) This change is due to budgetary constraints.


SECTION 2. This ordinance shall take effect and be in force from and after the earliest period allowed by law.


